

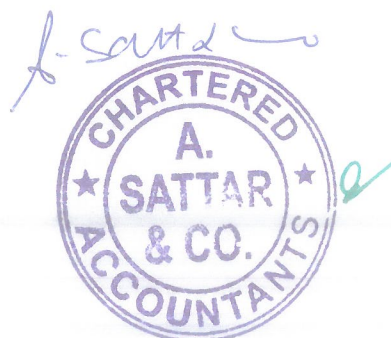

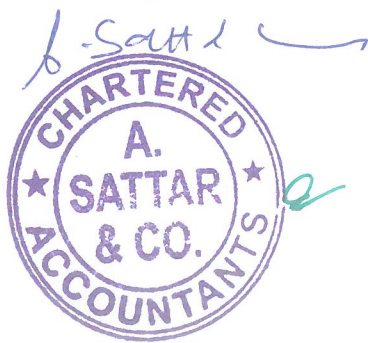

**1 CORPORATE INFORMATION**

**Catholic Diocese of Faisalabad** is a non-government and non-profitable organization established As the living body of Jesus Christ, in all our diversity and unity, we attempt to carry out the mission of Our Lord through Liturgy, Proclamation of the word of Fraternal Service to the poor and the needy and also for the wellbeing of the downtrodden children for their Socio-cultural empowerment regardless of race, color, sex and religion, human health and social activities. *Catholic Diocese of Faisalabad* is duly registered under the Societies Registration Act, XXI of 1860, under the Registration No. RJSC/FSD/2117/22/443

*Catholic Diocese of Faisalabad* activities are funded from donations, charity etc. appropriated by organization contribution and grants from local and foreign sources.

The registered office of *Catholic Diocese of Faisalabad* is Bishop's House Railway Road, Near Standard Chartered Bank, Faisalabad

The financial statements of the *Catholic Diocese of Faisalabad* for the year ended December 31, 2023 was authorized for issue by the *Catholic Diocese of Faisalabad* board of Directors on \_\_\_\_\_, 2024.

**2 SIGNIFACT ACCOUNTING POLICIES**

**(a) Statement of compliance**

The financial statements have been prepared with the accounting and reporting standards as applicable in Pakistan. The approved accounting and reporting standards applicable in Pakistan comprise of International Financial Reporting Standard for Small and Medium-size Entities (FRS for SMEs) issued by the International Accounting Standards Board (ASB) as notified under the Companies Act, 2017; Accounting Standard for Not for profit Organizations (Accounting Standards for NPOs) issued by the Institute of Chartered Accountants of Pakistan as notified under the Companies Act, 2017; and Provisions of and directives issued under the Companies Act, 2017.

Where provisions of and directives issued under the Companies Act, 2017 offer from the IFRS to SMEs or the Accounting Standards for NPOs, the provisions of directives issued under the Companies Act, 2017 have been followed.



### 3. BASIS OF PREPARATION OF FINANCIAL STATEMENTS

These financial statements have been prepared under the historical cost convention.

### 4. SIGNIFICANT ACCOUNTING POLICIES

#### (a) Functional and presentation currency

These financial statements are prepared in Pak Rupees, which is the functional and presentation currency for *Catholic Diocese of Faisalabad* and rounded off to the nearest rupee.

#### (b) Property, plant and equipment

Operating fixed assets are stated at cost less accumulated depreciation and impairment loss. Entity capitalizes all expenses incurred in connection with the acquisition or development of a tangible asset which has an economic useful life of the more than one accounting period.

Depreciation on all operating fixed assets is charged to income on written down value method so as to write off the historical cost of assets over estimated useful life.

Acquisitions during the year are depreciated proportionately, from date of purchase to accounting year end. Depreciation is also charged on assets sold during the year proportionately. Impairment Loss or its reversal, if any, is charged to income. Where an impairment loss is recognized, the depreciation charge is adjusted in the future periods to allocate the asset's revised carrying amount over its estimated useful life.

The gain or loss on disposal or retirement of an asset is recognized as an income or expense.

All operating fixed assets which have been recognized in financial statements are categorized according to their nature and acquired cost.

Furniture and equipment are stated at cost less accumulated depreciation. Depreciation is charged on reducing balance method at the following rates.

Building	5%
Vehicles	20%
Computer, Printer, IT Equipments	30%
Furniture and Fixture	10%

Normal repairs and maintenance expenses are charged to revenue.

Gains or losses on disposal of property, plant and equipment are included in current revenue.





## (c) Revenue and expense recognition

Revenue is recognized to the extent that it is probable that the economic benefits will flow to the *Catholic Diocese of Faisalabad* and revenue can be reliably measured. The following specific recognition criteria must also be met before revenue is recognized:

Revenue from restricted support is recognized upon fulfillment of the donor-imposed conditions attached to the support, and to the extent that expenses are incurred.

Revenue from unrestricted support is recognized upon receipt of the support and expenses are reported when incurred.

Restricted support for which restriction and conditions have not yet been met, are classified as deferred support. At project completion date, any excess funds in deferred support are to be returned to the donor unless otherwise agreed by both parties to be retained by the *Catholic Diocese of Faisalabad* and therefore credited to unrestricted support.

## (d) Cost of stationary

These are charged to income as and when incurred.

## (e) Taxation

The *Catholic Diocese of Faisalabad* being established solely for charitable purposes and not for the purposes or profit is exempt from taxation under clause 60 of Part I of the Second Schedule to the Income Tax Ordinance 2001, and hence the *Catholic Diocese of Faisalabad* income is not taxable. It is registered Federal Board of Revenue under the NTN number 8112630-4
